An Ordinance to license, and regulate businesses, trades, occupations, and professions in the City of Albany, Oregon, and for other purposes; and to provide punishment, for the violations thereof; and to repeal all ordinances in conflict therewith.

The People of the City of Albany do ordain
as follows:

Section 1. It shall not be lawful for any person, or persons to keep for pay within the corporate limits of the City of Albany, Oregon, any theater, show or public exhibition; any bowling alley, billiard table, pigeon hole table, or any other table upon which games are played with balls, and cues; or to engage in or carry on any business, trade, occupation, or profession, hereinafter enumerated, or own, and use any bicycle, without first having obtained a license therefor; as hereinafter provided. No peddler shall vend, sell, or retail a first sale any goods wares or merchandise except the agricultural products of the State of Oregon; No person, or persons shall sell any goods wares or merchandise at public auction, or sell or offer for sale, or take orders for any goods, wares, or merchandise by sample or otherwise at retail, to be delivered at the time, or at some future time, unless such person, or persons, shall have first obtained a license therefor in the manner hereafter provided for.

Section 2. Any person or persons applying for a license, as required by this Ordinance shall pay to the City Treasurer of the City of Albany the amount due for such license, and take a receipt therefor, specifying the amount so paid, the business, occupation, or profession intended to be pursued, any purpose for which a license may be wanted, and the length of time for which such license is to be issued.

Section 3. On presentation of such receipt to the City Recorder of said City of Albany, he shall issue a license to the person, or persons named in said receipt, in accordance with the terms thereof.

Section 4: No license shall be transferred, nor shall any license be annulled, or reinstituted, except by and with the consent, and approval of the City Council of said City of Albany.

Section 5: All licenses issued by the City Recorder of said City of Albany, except where otherwise provided herein, shall expire, on the first day of January, or July of each year, and shall not be for a term of less than six months, provided however that in the case of the application of a person, or persons, who were not in business on the first day of January or July of any year, said license may be issued for the remainder of the six months unexpired, and for the whole of the next succeeding six months, and the amount to be paid for the unexpired portion of said six months shall be a proportionate amount of the license fee, except in cases where it is otherwise provided.

Section 6: The following lines of business, trades, occupations, professions, and other things named shall be licensed, and the following rates shall be charged therefor, annually, except where it is herein otherwise especially provided, that the rate shall be for a shorter time to wit:

Section 7. Nothing in this Ordinance shall be construed so as to in any way interfere with or affect any license that has been issued to any person, or firm, to carry on any business, calling or occupation in the City of Albany, but the same shall be and remain in full force and effect, until the same expires by limitation. 189

shall any thing in this Ordinance be so construed as to effect, or repeal any Ordinance now in force in the City of Albany, whereby a license is imposed upon any business, trade, vocation or calling, unless the same is especially named, and designated in this Ordinance.

Section 8: Any person, or persons soliciting fire or life insurance in the City of Albany, for any insurance company, not having a licensed Agent within said City, shall be deemed an insurance Agent under this Ordinance.

Section 9: Any person, firm, or Corporation, who shall carry on any two, or more of the lines of business, enumerated above in keeping a store, and which have been distinctly and separately enumerated, and where the said two, or more lines of business are carried on under the same roof or in the same building such business may be deemed a general Merchandise store, and the proprietor may pay license accordingly.

Section 10: If any Circus or Menagerie, or sideshow shows or shows with shall exhibit contrary to this Ordinance, without first having obtained a license therefor, as herein provided, the proprietor, or agent, or agent of said Circus, or Menagerie, or Side Show, shall each and every one of them upon conviction thereof be fined in a sum not to exceed \$100.00, and the owner, agent, or agents of said Side Show, and each, and every of them, shall likewise be liable to a fine of not more than \$50.00 in case said Side Show shall exhibit contrary to this Ordinance.

Section 11: Any person or persons carrying on any business, occupation, or profession within the corporate limits of the City of Albany Oregon heretofore enumerated, without first having obtained a license therefor as heretofore provided shall upon conviction thereof before the City Recorder of said City of Albany, be fined in a sum not to exceed double the amount of the annual license fee of said business, occupation, or profession, and herein before set out.

Section 12: Any person, or persons adjudged to pay a fine under

This ordinance, shall be adjudged to pay the cost of the
jurisdiction, and shall upon the request in the payment
paid fine, and each, he committed to the city jail for a
period of one year for every two of said fine and to
extend fifty (50) days.

Section 13:

It is hereby made the duty of the City, Oregon, and
City of Albany, Oregon, on the 28th day of June and thereafter
of each year to report in the Court of the City of Albany
Licenses for, a notice printed in plain type, stating
effect, that fine, for or their license will expire on the
first day of the morning month, and that the day, or
they, must procure a new license before the first day of
the said morning month, that no further notice will be
given.

Section 14:

It shall be, and it is hereby made the duty of the City,
Municipality of Albany, Oregon, to immediately
proceed as by law, and ordinances of said City provide,
against any, and all persons who shall on the 1st day
of January, and the 1st day of July of each year be found
carrying on within the corporate limits of said City of Albany,
Oregon, without first having obtained a license therefor,
any business, trade, occupation, or profession, for which a
license has been, or may hereafter be provided by an ordinance
of said City of Albany, Oregon, and at any time between
said date, after notice either verbal or written given by
said City, Marshal to any party violating any of the terms of
this ordinance.

Section 15:

Each City license under this ordinance for which the fee
is \$100 per annum, or less, except other otherwise provided
shall be payable annually, and such license shall not
be issued for a term less than one year, and all licenses
which the fee exceeds \$100 may be paid semi-annually
at the option of the party taking out said license, and
all licenses are payable in advance.

Section 16:

That the City Recorder shall receive and file conformable
for his services in issuing licenses under this ordinance,
and giving all notices required here (S) for each of
years a statement of the fees received on such licenses.

to be paid out of the City Treasury. Provided however, for all Saloon Licenses, and Licenses for Shows, and Theatrical entertainments, the Recorder shall be allowed to charge, and collect the fees now allowed by Ordinance, for issuing such licenses, the same to be paid partly or partly apply therefor.

Section 17: That all Ordinances, or parts of Ordinances, now in force, that are in conflict with this Ordinance or any part thereof, be, and they are hereby repealed, except as herein before provided: Provided however that nothing in this Ordinance shall in any way affect any Ordinance, or Ordinance now in force providing for licensing Saloons, or places for the sale of Spirituous, Vinous, or Malt liquors in less quantities than one quart.

Section 18: That this Ordinance take effect, and be in force from and after the first day of July 1899, and that the same shall expire by limitation, on and after the first day of July 1901.

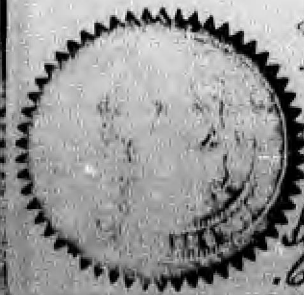
