

ORDINANCE NO. 529.

Amendment to Charter issuing Sewer Bonds \$40,000.00

Ord No 529 An Ordinance entitled an Ordinance directing and Amendment authorizing the submission to the Legal Voters of Albany, Oregon, for their adoption or rejection, of a proposed Sewer Bond^s issuing amendment to the Charter of said City, at the next regular election to be held in said City, which amendment authorizes and directs the issuance and sale of negotiable interest bearing bonds in a sum not to exceed forty thousand dollars for the construction of sewers in said City, from the proceeds of the sale of which said bonds the expenses of constructing said sewers shall be defrayed.

The People of the City of Albany do ordain as follows:

Section 1. That at the next regular election to be held in the City of Albany, the following proposed amendment to the Charter of the said City of Albany, Oregon shall be submitted to the legal voters of said City for their adoption or rejection, to-wit:—

An Act entitled "An Act to amend an act entitled an act to incorporate the City of Albany, and to provide a Charter therefor, and to repeal all acts and parts of acts in conflict therewith;" passed the Legislative Assembly of the State of Oregon, and approved February 16th, 1901, as amended by an act entitled "An Act to amend Section 34 of Chapter 4 and Sections 43 and 51 of Chapter 6 of an Act entitled "An act to incorporate the City of Albany, and to provide a Charter therefor, and to repeal all acts and parts of acts in conflict therewith," passed the Legislative Assembly of the State of Oregon, and approved February 24, 1903, (by providing for and authorizing the issuance and sale by said City of negotiable interest bearing bonds in the sum of not more than forty thousand dollars for the construction of sewers in said City and to defray the expenses thereof

Be it Enacted by the Legal Voters of the City of Albany, Oregon:

The People of the City of Albany do ordain as follows, to-wit:

Section 1. That an Act entitled "An Act to incorporate the City of Albany, and to provide a Charter therefor, and to repeal all acts or parts of acts in conflict therewith;" passed the Legislative Assembly of the State of Oregon, and approved February 16th, 1901, as amended by an

Act entitled "An Act to amend Section 34 of Chapter 4 and Sections 43 and 54 of Chapter 6 of an Act entitled "An Act to incorporate the City of Albany and to provide a Charter therefor, and to repeal all Acts and parts of Acts in conflict therewith", passed the Legislative Assembly of the State of Oregon and approved February 24th 1903, be and the same are hereby amended by adding thereto, the following to-wit:

Section 170. The City of Albany by and through its Common Council shall have the power and authority, and is hereby authorized and directed to construct, use, maintain, operate and control certain sewers at such places, of such size, and in such manner as may by said Council be deemed suitable and proper in the City.

Section 171. For the purpose of carrying the provisions of this Chapter into effect, the Common Council shall have the power and authority and is hereby expressly authorized, empowered and directed to issue negotiable interest bearing bonds to the amount of not more than forty thousand dollars to defray the expenses of digging and constructing said sewers. Said bonds to be in addition to the present bonded debt of the city, said bonds to bear such rate of interest and to be payable at such times and in such amounts as the Council may by ordinance determine, said bonds to bear interest not to exceed five per centum per annum, and to be sold for not less than par, and to run not more than twenty years; said bonds shall be issued under the corporate seal of the City of Albany, signed by the Mayor, and countersigned by the City Recorder of said City of Albany.

Section 172. The Common Council of the City of Albany shall have the power and authority, and it is hereby expressly authorized to submit and award any and all contracts necessary or expedient for the construction of said sewers, or any part thereof, or to proceed to the construction of the same, or any part thereof, without contract, and to this end the Common Council is hereby empowered and authorized to employ, hire, retain, contract with, pay and discharge all such agents, architects, surveyors,

builders, engineers, contractors, workmen, laborers, servants and other persons, firms and corporations and to purchase such material as it may seem necessary or convenient or proper, to the end that said sewers may be properly constructed and maintained; and said Common Council is hereby authorized to provide by resolution or ordinance for receiving bids for the construction of any portion of said sewer, or for either labor or materials entering into the same, and for the award of contracts therefor, imposing such conditions upon bidders with regard to bids, and securities and guarantees for the good faith and responsibility of builders and for insurance of the faithful completion of the work in accordance with the plans and specifications therefor as it may seem advantageous to the City.

Such contract or contracts shall be let to the bidder or bidders whose bid or bids the Common Council in its discretion shall deem most advantageous to the City.

The Council shall have the right to reject any and all bids received and without re-advertisement let a contract for the whole, or any part, of the construction of said sewers as deemed by said Council most advantageous to the City.
