

Lawlor, Albany, Oregon

An Ordinance providing for the time and manner of improving Main Street from the South line of Water Street to the south line of Fourth Street, providing how the cost of such improvement shall be paid, the penalties or damage to the City of Albany by the person or persons making such improvement, if the same shall not be completed within the time agreed upon, and the giving of a good and sufficient bond for the faithful performance of the work of such improvement of said part of said street, and providing for the giving by the Recorder of said City of proper notice, or bids for the completion of such improvement of said part of said street.

The People of the City of Albany Do Ordain As Follows:

Section 1. That Main street from the south line of Water Street to the south line of Fourth Street shall be improved in the following manner, to-wit:

- First: By grading said street to the proper subgrade.
 Second: By paving the roadway of said street full width with full intersections with asphaltic concrete pavement or an asphaltic overlay construction.
 Third: By raising and constructing asphaltic concrete headers.
 Fourth: By constructing catch basins.
 Fifth: By constructing inlets.
 Sixth: By laying vitrified sewer pipe.
 Seventh: By laying sub-drain tile.

Said improvement to be made in accordance with the charter and ordinances of the City of Albany, Oregon, and the present specifications and estimates of the City Engineer of said City for the improvement of said street, filed in the office of the Recorder of said City of Albany, Oregon, on the 25th day of April, 1905, and endorsed "Specifications and specifications for the improvement of Main Street from the south line of Water Street to the south line of Fourth Street and the estimate of the work to be done and the probable cost thereof."

The cost of said improvement of said portion of Main Street shall be paid out of the funds collected and arising here and out of the assessments hereafter to be made, ascertained and declared by the Council of the City of Albany on the lots and parts of lots adjacent to said portion of said Main Street to be improved, and the details and particulars involved therein as provided in the charter

The said improvement of said portion of said Main Street shall be completed by the 10th day of October, 1915.

Any bids for the execution of said improvement of said street deemed unnecessary by the Council of the City of Albany may be rejected.

Any firm, person or corporation with whom any contract made in pursuance of the City of Albany, or the making of said improvement shall, prior to commencing said improvement and at the time of making such contract, make, execute and deliver to said City a good and sufficient bond, with good and sufficient surety, in the sum of Two Thousand Dollars for the faithful performance of such contract.

Section 2. If the person, firm or corporation entering into any contract with the said City of Albany to make said improvement of said Main Street shall not complete the same within the time mentioned and specified in such contract, said city shall be deemed to suffer damages on account thereof to the amount of \$25.00 per day for each and every day the completion of said work is delayed beyond the time stated in such contract, which amount shall be paid to said contractor doing the work at the completion thereof unless the time of completion of said improvement is extended by the Council.

Section 3. The Recorder of said City is hereby ordered and directed to immediately give proper notice, or bids for the making of said improvement of said portion of said Main Street by the making of such notice to be kept in the Albany Jail, and to deliver such notice to the said City of Albany, fully described in said notice, and to advise of doing the work of said improvement to said Main Street.
