

ORDINANCE NO. 960.

AN ORDINANCE PROVIDING FOR THE PURCHASE BLOCK 48 OF HAZELWOOD ADDITION TO THE CITY OF ALBANY, OREGON, AND APPROPRIATING THE NECESSARY FUNDS FOR THE PAYMENT THEREFORE,

WHEREAS THE COUNCIL OF THE CITY OF ALBANY HAS HERETOFORE AGREED TO PURCHASE BLOCK 48 OF HAZELWOOD ADDITION TO THE CITY OF ALBANY FROM W. H. HOWARD; AND

WHEREAS THE SAID W. H. HOWARD HAS DEPOSITED IN THE ALBANY STATE BANK A WARRANTY DEED CONVEYING TO THE CITY OF ALBANY SAID BLOCK 48 OF HAZELWOOD ADDITION TO THE CITY OF ALBANY WITH INSTRUCTIONS TO SAID BANK TO DELIVER SAID DEED UPON THE RECEIPT BY SAID BANK OF GENERAL FUND WARRANTS IN THE SUM OF \$900.00.

THEREFORE:

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That the sum of \$900.00 is hereby appropriated from the general funds of the City of Albany in payment of the purchase price for Block 48 of Hazelwood Addition to the City of Albany, Oregon, and the Recorder of said City is hereby directed to draw one warrant in the sum of \$650.00 in favor of W. H. Howard and one warrant in the sum of \$250.00 in favor of Albany College to be charged against the sum hereby appropriated.

Section 2. That the Recorder of said City is hereby directed to deliver said warrants to the Albany State Bank upon the receipt by said Recorder from said Bank of a deed executed February 13th, 1920, by W. H. Howard and wife, conveying to the City of Albany said Block 48 of Hazelwood Addition to the City of Albany, together with a partial release of a mortgage held by said Albany College against said property. Upon the receipt by said Recorder of said deed and said partial release of mortgage, the said Recorder is directed to file the same for record in the office of the County Recorder of Linn County, Oregon and to draw the necessary warrants in payment of the recording fees.


