

# ORDINANCE NO. 1017.

AN ORDINANCE DECLARING A SURPLUS ON ACCOUNT OF THE IMPROVEMENT BY L.O. HERROLD ON THIRD STREET FROM THE EAST CURB LINE OF CALAPOOIA STREET TO THE WEST LINE OF VINE STREET IN THE CITY OF ALBANY, OREGON, AND DIRECTING THE RECORDER OF THE CITY OF ALBANY TO PLACE TO THE CREDIT OF THE SEVERAL OWNERS OF THE VARIOUS PARCELS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT, HERETOFORE ASSESSED AND ENTERED OF RECORD IN THE DOCKET OF CITY LIENS IN THE CITY OF ALBANY, OREGON, FOR MAKING SUCH IMPROVEMENT, THEIR PROPORTIONATE SHARE OF SUCH SURPLUS.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section I. THAT A SURPLUS OF \$ 525.35 is hereby ascertained, determined and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon, and L.O. Herrold for the improvement of Third Street from the East curb line of Calapooia Street to the West line of Vine Street in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.

Section II. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens in the surplus column thereof a credit in favor of the following named persons, owners, or reputed owners of such parcels of real estate and in the sums as follows, to-wit:

Beginning 50 ft. N. of the N.E. corner of Lot No. 4 in Block No. 24 in the City of Albany, Oregon, thence W. to the N.W. corner of Lot No. 3 of said block thence southerly on the W. line of said Lot No. 3 60 ft. thence easterly parallel with the N. line of said block 48 ft. thence 60 ft. to beginning.

Beginning at the N.E. corner of Lot No. 4 in Block No. 24 in the City of Albany, Oregon, thence W. 30 feet thence S. 60 feet, thence East 30 feet, thence North 30 feet to beginning; above boundary lines to run parallel with boundary lines of said block.


