

ORDINANCE NO. 1152

A BILL FOR AN ORDINANCE Authorizing and directing the Recorder of the City of Albany to cancel certain street improvement assessment liens upon payment to the City Treasurer of the City of Albany of the sum of Three Hundred Two and Forty Two Hundredths Dollars (\$302.42) and filing in the office of the City Recorder of the City of Albany, Oregon, a duplicate receipt therefor.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

That Whereas, the City of Albany has heretofore levied an assessment upon the South one-half of Block No. 110 in Hackleman's Addition to the City of Albany for the improvement of Second Street; and

WHEREAS, the owner of the East one-half of the Southwest quarter of said Block No. 110 desires to satisfy the pro rata assessment against said portion of said block; and

WHEREAS, said assessment heretofore levied by the City of Albany against said Block No. 110 in Hackleman's Addition to the City of Albany, Linn County, Oregon, has been duly entered in the Bond Lien Docket of the City of Albany in volume 3, at Page 83 thereof; and

WHEREAS, the proportion of said assessment against the East one-half of the Southwest quarter of Block No. 110 in Hackleman's Addition to the City of Albany is the sum of Three Hundred Two and Forty Two Hundredths Dollars (\$302.42) which said assessment was levied against said property in the name of Peter Riley.

Section 1. The City Recorder of the City of Albany be and he is hereby authorized and directed, upon the payment of the sum of Three Hundred Two and Forty Two Hundred Dollars (\$302.42) to the City Treasurer of the City of Albany, Oregon, and the filing of a duplicate receipt therefor with said City Recorder, which said payment shall be made as the amount of the street assessment due the East one-half of the Southwest Quarter of Block No. 110 in Hackleman's Addition to the City of Albany, Linn County, Oregon, to cancel and mark as satisfied the lien now subsisting in favor of the City of Albany on the East one-half of the Southwest quarter of said Block No. 110 in Hackleman's Addition to the City of Albany, Oregon.
