ORDINANCE NO. 1312

AN ORDINANCE declaring a surplus on account of the improvement by U.G. Hayne of Seventh Street from the east line of Denver Street to the south curb line of Santiam Road in the City of Albany, Oregon, and directing the Recorder of said City to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed and entered of record in the Docket of City Liens of the City of Albany, Oregon, for making such improvement, their proportionate share of said improvement.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$3.22 is hereby ascertained and declared to exist upon the completion of the contract entered into between the City of Albany, Oregon, and U.G. Hayne, for the improvement of Seventh Street from the east line of Denver Street to the south curb line of Santiam Road, in Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of such improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens, in the surplus column thereof, the aggregate sum of \$3.22, based upon the several amounts heretofore assessed and entered therein to defray the costs of improving said Street, said surplus being in favor of the following named persons, owners, or reputed owners of the various parcels of real estate, and in the sums as follows, to-wit:


