

ORDINANCE NO 1253

AN ORDINANCE declaring a surplus on account of the construction of a lateral sewer by U.G.Hayne, beginning at the north end of the lateral sewer now in place, which is at the southeast corner of lot 2 in block 1 in Albany Height's Addition to the City of Albany, Oregon; thence running northerly through the center of block 1 and block 2, in said addition,, to the northeast corner of lot 7 in block 2 in said Addition, a distance of 770 feet, and directing the Recorder of said City to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed and entered of record in the Docket of City Liens of the City of Albany, Oregon, for the making of said improvement, their proportionate share of such surplus.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$113.82 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into by and between the City of Albany, Oregon, and U.G.Hayne, for the construction of lateral sewer beginning at the north end of the lateral sewer now in place, which is at the southeast corner of lot 2 in block 1 in Albany Height's Addition to the City of Albany, Oregon; thence running northerly through the center of block 1 and block 2 in said Addition, to the northeast corner of lot 7 in block 2 in said addition, a distance of 770 feet, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens of said City, in the surplus column thereof, the sum of \$113.82, based upon the several amounts heretofore assessed for making such improvement and entered therein to defray the cost of the construction of said lateral sewer, said surplus being in favor of the various owners, or reputed owners, of the various parcels of real estate, and in the sums as follows, to-wit:
