

ORDINANCE No. 1867

A BILL FOR:

AN ORDINANCE declaring a surplus on account of the construction of lateral sewers as follows:

HACKLEMAN STREET LATERAL 8 - Beginning at manhole on Hackleman Street main 21 feet north of the south side of Hackleman Street and running thence southerly between Hackleman's Sunrise Addition and Epauline Addition 1054 feet. Also sub-laterals as follows:

- (a) Through center Block 1, Epauline Add., 127 feet.
- (b) Through center Blocks 4, 5, & 6, Epauline Add., 595 feet.
- (c) Through center Blocks 7, 8, & 9, Epauline Add., 553 feet.
- (d) Through center Blocks 10, 11, & 12, Epauline Add., 536 feet.
- (e) Beginning at manhole 23 ft. north of the northwest corner of Lot 1, Block 13, Epauline Add., and running thence east 171.6 ft., thence southeasterly 125 feet to the manhole 18 ft. west of property, thence east 357.5 ft. through center of blocks 14 & 15, Epauline Add.

Also, 172 feet through center of west portion of Block 2, Supplemental Epauline, and 180 ft. through center of the east portion of Block 2.
Also, 131 ft. servicing Block 3, Epauline Addition.

in the City of Albany, Linn County, Oregon, by Leonard & Slate Oreg. Ltd., and directing the Recorder of said City to place to the credit of the several owners of the various parcels of real estate improved by the construction of lateral sewers heretofore assessed and entered of record in the Docket of City Liens of the City of Albany, Oregon for the construction of said lateral sewers, their proportionate share of such surplus.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$1071.29 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into, by and between the City of Albany, Oregon, and Leonard & Slate Oreg. Ltd. for the construction of lateral sewers as follows:

Hackleman Street Lateral 8 - Beginning at manhole on Hackleman Street main 21 ft. north of the south side of Hackleman Street and running thence southerly between Hackleman's Sunrise Addition and Epauline Addition 1054 feet. Also sub-laterals as follows:

- (a) Through center of Block 1, Epauline Add., 127 feet.
- (b) Through center Blocks 4, 5, & 6, Epauline Add., 595 ft.
- (c) Through center Blocks 7, 8, & 9, Epauline Add., 553 ft.
- (d) Through center Blocks 10, 11, & 12, Epauline Add., 536 ft.
- (e) Beginning at manhole 23 ft. north of the northwest corner of Lot 1, Block 13, Epauline Add., and running thence east 171.6 ft., thence southeasterly 125 ft. to the manhole 18 ft. west of property, thence east 357.5 ft. through center of Blocks 14 & 15, Epauline Add.

Also, 172 ft. through center of West portion of Block 2, Supplemental Epauline, and 180 ft. through center of the east portion of Block 2, also 131 ft. servicing Block 3, Epauline Addition.

in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate improved by the construction of lateral sewers heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens of said City, in the surplus column thereof, in the sum of \$1071.29 based upon the several amounts heretofore assessed for constructing such lateral sewers, said surplus in favor of the various owners, or reputed owners, of the various parcels of real estate, and in the sums as follows, to-wit:
