

ORDINANCE NO. 1882

A BILL FOR:

AN ORDINANCE declaring a surplus of \$192.35 on account of construction of Montgomery Street Lateral No. 2 as follows:

Through center of Block 2, along East line of Lots 1, 2, 3 and 4; and along West line of Lots 18, 19, 20 and 21; all in Block 2, Bacon's Addition to the City of Albany, Oregon.

The changes as represented are the surpluses which arose from the fact that there have been some changes in ownership and the amount of work to be done as compared with the engineer's original estimate.

In the City of Albany, Linn County, Oregon, by D. F. McKenzie and O. L. Bowman, and directing the Recorder of said city to place the surplus to the credit of the various parcels of real estate improved by the construction of lateral sewers heretofore assessed and entered of record in the Docket of City Liens of the City of Albany, Oregon for the construction of said lateral sewers, their proportionate share of such surplus.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$192.35 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into, by and between the City of Albany, Oregon, and D. F. McKenzie and O. L. Bowman, for the construction of lateral sewers as follows:

MONTGOMERY STREET LATERAL NO. 2. Through center of Block 2; along East line of Lots 1, 2, 3 and 4 and along West line of Lots 18, 19, 20 and 21; all in Block 2, Bacon's Addition to the City of Albany, Oregon, and the surplus in favor of the several owners of the various parcels of real estate improved by the construction of lateral sewers heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens of said City, in the surplus column, the sum of \$192.35 based upon the several amounts heretofore assessed for construction of lateral sewers, said surplus in favor of the various owners in the various parcels of real estate in the sums as follows, to-wit:
