

ORDINANCE NO. 1894

AN ORDINANCE levying a tax for the City of Albany, Oregon upon the current assessment made upon the taxable property within said City for the fiscal year beginning July 1, 1948 and ending June 30, 1949, for taxes to become due and payable upon such assessment for said period and to separately appropriate for each department of said City Government and other public expenses thereof the amount of taxes so levied as provided by law.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That it is hereby determined, declared and levied, taxes in and for the City of Albany, Oregon, based upon the current assessment made upon the taxable property in said City for the fiscal year beginning July 1, 1948 and ending June 30, 1949, said taxes to become due and payable within said period in sums as follows:
