

ORDINANCE NO. 2223

AN ORDINANCE DECLARING A SURPLUS AND A DEFICIT ON ACCOUNT OF THE IMPROVEMENT OF THE ALLEY BETWEEN THIRD AND FOURTH AVENUES FROM THE WEST LINE OF ELLSWORTH STREET TO THE EAST LINE OF BROADALBIN IN THE CITY OF ALBANY, LINN COUNTY, OREGON, AND DIRECTING THE RECORDER OF SAID CITY TO PLACE TO THE CREDIT OR DEBIT OF THE SEVERAL OWNERS OF THE VARIOUS PARCELS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT HERETOFORE ASSESSED AND ENTERED ON THE RECORD IN THE DOCKET OF CITY LIENS OF THE CITY OF ALBANY, OREGON FOR THE MAKING OF SAID IMPROVEMENT, THEIR PROPORTIONATE SHARE OF SUCH SURPLUS OR DEFICIT.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$90.06 and a deficit of \$14.24 are hereby declared to exist upon the completion of the contract heretofore entered into for the improvement of the alley between Third and Fourth Avenues from the west line of Ellsworth Street to the east line of Broadalbin in the City of Albany, Linn County, Oregon and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens for said City in the surplus column and deficit columns thereof, in the sum of \$90.06 and \$14.24, respectively, based upon the several amounts heretofore assessed for making such improvement and entered therein to defray the cost of the improvement of said street, said surplus or deficit and to credit or charge the respective individuals and the parcels of real estate, and in the sums as follows, to-wit:
