Ordinance No. 2865

TITLE: AN ORDINANCE PROVIDING FOR THE DATE AND MANNER OF HOLDING A SPECIAL ELECTION IN A PORTION OF RODGERS ACRES ADDITION ON THE 23RD DAY OF OCTOBER, 1959 FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE SAID TERRITORY FOR THEIR ADOPTION OR REJECTION A PROPOSAL TO ANNEX THE SAID PORTION OF RODGERS ACRES ADDITION TO THE CITY OF ALBANY, OREGON, AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: DAY AND TIME FOR ELECTION

That in a manner provided by law and in this Ordinance and for the purpose set forth herein, a special election shall be held in a portion of Rodgers Acres Addition, Linn County, Oregon, as below described on the 23rd day of October, 1959 commencing at the hour of 8 o'clock a.m. on the said day, Pacific Standard Time.

Section 2: VOTING PLACE

That the following is hereby designated as the voting place of the said election: At 3840 Geary Street, Albany, Oregon.

Section 3: JUDGE AND CLERKS

That the Judge and Clerks of the said special election who shall supervise the election within the below described territory, shall be:

Mrs. Dolores Nova, Clerk
Mrs. Alma Hobbs, Clerk

Section 4: NOTICE

The City Recorder shall cause notice of the said special election to be given by publication thereof in a newspaper of general circulation within the city once a week for four (4) consecutive weeks, first date of publication to be the 25th day of September, 1959, and said notice shall state the time, voting place and description of the territory proposed to be annexed.

Section 5: POSTED NOTICES

The Recorder, in addition to the notice required in Section 4 above, shall cause to be posted in four (4) conspicuous places within the territory proposed to be annexed at least ten (10) days before the date of the special election, notices of the special election in the following form:

"SPECIAL ELECTION NOTICE"

NOTICE IS HEREBY GIVEN that on the 23rd day of October, 1959 at 3840 Geary Street, Albany, Oregon, a special election will be held concerning the proposed annexation of the following described territory to the City of Albany, to-wit:

Tracts 19 to 29, inclusive, Rodgers Acres Addition,
Linn County, Oregon.

which election will be held at 8 o'clock in the morning and will continue until 8 o'clock in the afternoon Pacific Standard Time of said day.

Registered voters in said territory are invited to vote upon the proposed annexation.

Section 6: PURPOSE OF ELECTION

At the said special election, the proposed annexation of the territory described below shall be submitted to the legal voters of the said territory for their adoption or rejection as hereinafter set forth in Section 7.

Section 7: SAMPLE BALLOT

The ballot title of the proposed annexation submitted to the registered voters of the said territory shall be as follows:

"PROPOSAL TO ANNEX A PORTION OF RODGERS ACRES ADDITION TO THE CITY OF ALBANY, LINN COUNTY, OREGON.

AN ACT to annex the following described territory, (being a portion of Rodgers A res Addition, Linn County, Oregon) to the City of Albany:

Tracts 19 to 29, inclusive, Rodgers Acres Addition, Linn County, Oregon.

Section 8: EMERGENCY CLAUSE:

Inasmuch as the special election and the dates of holding the same must, for the convenience, peace and health and safety of the citizens of the City of Albany and the said territory be held on the date aforesaid, an emergency is hereby declared and this ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
