

ORDINANCE NO. 3004

AN ORDINANCE PROVIDING FOR THE DATE AND MANNER OF HOLDING A SPECIAL ELECTION IN THE CITY OF ALBANY, OREGON, ON THE 7TH DAY OF MARCH, 1962, FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE CITY OF ALBANY THE FOLLOWING:

- (1) A special continuing 10 year levy of \$15,000 per year outside the 6% limitation to be used for the employment of additional police personnel and police equipment;
- (2) A special continuing 10 year levy of \$50,000 per year outside the 6% limitation to be used for the construction of fire substations and payment of additional firemen for manning said station and equipping the same;
- (3) A special levy of \$6,000 for one year only for the construction of traffic signals at Queen and Elm Streets, the levy to be outside the 6% limitation;
- (4) A special levy of \$6,000 for one year only for the construction of traffic signals at Second and Broadalbin Streets, the levy to be outside the 6% limitation;
- (5) A special levy of \$7,000 for one year only for railroad crossing signals at Second and Lafayette Streets, the levy to be outside the 6% limitation;
- (6) A special levy of \$3,000 for one year only to be used for traffic signals for fire truck access to Ellsworth Street Bridge, said levy to be outside the 6% limitation;

ALL OF THE MEASURES TO BE SUBMITTED TO THE VOTERS FOR ADOPTION OR REJECTION AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: TIME AND MANNER OF ELECTION

In the manner provided by law and this ordinance and for the purposes set forth herein, a special election shall be held in the City of Albany, Oregon, on the 7th day of March, 1962, commencing thereon at 8 o'clock a.m. of said day and continuing until 8 o'clock p.m. of said day.

Section 2: VOTING PLACES

The following are designated as voting places for the said election:

FIRST WARD - Maple School
SECOND WARD - Fire Station
THIRD WARD - Waverly School

Section 3: JUDGES AND CLERKS

The judges and clerks of the special election to supervise the election in each of the within wards of the City of Albany shall be as follows:

Section 4: OATH

The judge and clerks shall qualify by subscribing to an oath in the manner and form provided by law and in case any such officer shall fail to attend, then those present shall elect another to act in his place.

Section 5: NOTICE OF SPECIAL ELECTION

The City Recorder shall cause notice of said special election to be given by publication thereof in a newspaper of general circulation published in the City of Albany at least once a week for two successive weeks; the first publication shall be with fifteen (15) days next preceding the date of the special election. Said notice shall state the time, voting places and a statement of the substance of the matters to be voted upon.

Section 6: POSTING OF NOTICE

The City Recorder, in addition to the notice required in Section 5, shall cause to be posted in ten (10) conspicuous places in each of the three (3) wards, at least ten (10) days before the date of the special election, notice of the special election in the following form:

"SPECIAL ELECTION NOTICE"

NOTICE IS HEREBY GIVEN that on the 7th day of March, 1962, at (location) in the _____ ward in the City of Albany, Oregon, a special election will be held referring to the people of the City of Albany for their adoption or rejection, the following special tax matters:

- (1) A special tax levy to increase police protection. An act to provide for special continuing ten (10) year levy of \$15,000 per year outside the 6% limitation, beginning in the year 1962-63 for the use of employment and equipping of additional policemen in the City of Albany.
- (2) A special tax levy for additional fire protection. An act to provide for a special continuing ten (10) year levy of \$50,000 per year outside the 6% tax limitation, beginning in the year 1962-63, for the use of erecting a fire substation, equipping and manning the same within the City of Albany.
- (3) A special tax levy for a traffic signal at Queen and Elm Streets. An act to provide for a special levy of \$6,000 for one year only outside the 6% tax limitation for the tax year 1962-63 to be used for traffic signals at the intersection of Queen Avenue and Elm Street in the City of Albany.
- (4) A special tax levy for traffic signals at Second Avenue and Broadalbin Street. An act to provide for a special tax levy of \$6,000 for one year only outside of the 6% tax limitation for the tax year 1962-63 to be used for traffic signals at the intersection of Second Avenue and Broadalbin Street in the City of Albany.
- (5) A special tax levy for traffic signals at railroad crossing at Second Avenue and Lafayette Street. An act to provide for special tax levy of \$7,000 for one year only outside of the 6% tax limitation for the tax year 1962-63 to be used for traffic signals at the intersection of Second Avenue and Lafayette Street in the City of Albany.
- (6) A special tax levy for traffic signals on Ellsworth Street during fire truck use. An act to provide for a special tax levy of \$3,000 for one year only outside the 6% limitation for the tax year 1962-63 to be used for traffic signals on Ellsworth Street at the times the same is being used by emergency fire vehicles.

At the special election, there shall be submitted to the legal voters for their adoption or rejection those matters hereinafter set forth in Section 8.

Section 8: BALLOT FORM

The following is the form in which the questions shall be printed on the official ballot:

"Vote YES or NO. Mark an 'X' in the square for the answer voted for.

- (1) A special tax levy to increase police protection. An act to provide for special continuing ten (10) year levy of \$15,000 per year outside the 6% limitation, beginning in the year 1962-63 for the use of employment and equipping of additional policemen in the City of Albany.
