

## ORDINANCE NO. 388

Passed May 24<sup>th</sup> 1904.Ord 388

An Ordinance authorizing and directing the building and laying of a cement or artificial stone sidewalk and curbing on the east side of Lyon Street on the west line of the north half of lot No. 1 and 2 in block No. 4 in the eastern addition to the City of Albany Oregon being the property of Sophia Baumgart, and to authorize the Mayor and Recorder of said City of Albany to enter into a contract on the part of and on behalf of the City of Albany for the construction of the same and providing for the expenses of the building and laying of said sidewalk to be assessed to the owners and holders of lots or parts of lots abutting and adjoining said sidewalk.

The People of the City of Albany do Ordain as follows:

Section I. - That there be constructed on the East side of Lyon Street abutting on and adjacent to the West line of the North Half of Lots one and two in Block No. 4 in the Eastern addition to the City of Albany Oregon a cement or artificial stone sidewalk and curbing and that the Mayor and Recorder of the said City of Albany be and they are hereby authorized and empowered to enter into and sign on the part of the City of Albany written articles of agreement for the construction and laying of said cement or artificial stone sidewalk eight feet in width and a regulation curbing along the East side of Lyon Street abutting the West line of the above described property. That the cost of the construction laying and building of said sidewalk and curbing be assessed to the owner or owners of lots and parts of lots abutting on and adjacent to said sidewalk when constructed, Provided that said contract shall not be entered into or such articles of agreement signed by the Mayor and Recorder on the part of said City, until after proposals for the construction of said side-

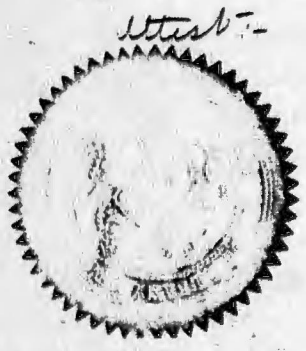

walk and curbing have been advertised for in the manner provided for by the City Charter and ordinances of the City of Albany regulating and awarding contracts, and bids have been received and considered by the Council and the contract awarded by the Council and the costs and expenses for the construction of said sidewalk curbing shall have been fixed and determined.

Section II: This ordinance shall be in full force and effect from and after its approval by the Mayor.
