

ORDINANCE NO. 1121

Contract for lights with Albany Canal Water Co.
Passed Nov. 14th 1905

Ord 412 By Ordinance authorizing and directing a contract with
Contract the Albany Canal & Water Company for electric lighting
per league for the term of five years,

with The People of the City of Albany do ordain as follows:—

Albany Sec. 1. That the offer of the Albany Canal & Water Company
Canal to furnish the City of Albany with electric lighting for the
Water Co. term of five years, upon the terms and conditions set
Passed forth in said offer, he and the same is hereby accepted,
11-14-5 said offer being in words and figures as follows:—

"The undersigned the Albany Canal & Water Company, a
corporation hereby offers to furnish to the City of Albany, Oregon, for the term of
five years, commencing on the 1st day of November 1905 and continuing
to the 1st day of November 1910, the following electric light service
upon the following terms and conditions, to wit:—

The said Company will furnish, supply and maintain at such places within
said city of Albany as may be designated by the Common Council of
said city and at a height of from thirty to thirty five feet from
the ground, so as to give the most efficient service, twenty electric arc lights,
general electric arc, or its equal, to operate not less than 6 3/4 amperes,
each to be kept burning continuously during the entire night time, that
is from the time darkness begins in the evening until daylight of
the following morning, provided that a reasonable time not
exceeding five per cent, shall be allowed for lights out on account
of accident or unavoidable delay - for the sum of \$140 per
month, to be paid by said city monthly, being at the rate of \$7.00
per month per light,

And the said Company will also furnish, supply and maintain
within said city at such places as may be designated by the
Common Council of said city such additional electric arc
lights of the same power and for the same time of service as the
twenty lights above mentioned as may from time to time
be ordered by the common council of said city for the sum of
\$4.00 per month per light to be paid by said city monthly from
the time of the installation of each of said lights until the
expiration of the above term; provided however that when
the whole number of said arc lights taken by said
city shall aggregate thirty in number, then the rate
per lamp to be paid by said city shall be \$6.75 per month
and when the whole number of said arc lights taken by
said city shall aggregate thirty five in number then
the rate per lamp to be paid by said city shall be \$6.50
per month; and when the whole number of said

arc lights taken by said city shall aggregate fifty in number, then the rate per lamp to be paid by said city shall be \$6.00 per month.

And the said company will also furnish, supply and maintain the following incand lights within said city of Albany for the sum of \$4.00 per month to be paid monthly by said city, to wit:

Recorder's office 2 16 c.p. lamps to be used during office hours.

Jail 2 16 c.p. lights, all night service.

City stables 2 16 c.p. lamps all night service and 4 16 c.p. lamps to be used when actually necessary and when some person is at the stables.

Street service 1 25 c.p. lamp at C. & E. Bridge, all night service.

and the said company will furnish, supply and maintain all the necessary electric lighting for each and every fire house now used or which may hereafter be used by the city of Albany or by any fire engine, hook & ladder company, or hose company of said city, free of charge to said city during the above term said lights being now distributed as follows:

Engine House No. 1. 3 - 16 c.p. lamps all night service;

" " " 3 - 16 c.p. " to be used when hall is in actual use.

Engine House No. 2. Hall 2 16 - c.p. and 1 - 25 c.p. lamp to be used when hall is in actual use;

Engine House No. 2. 4 - 16 c.p. lamps all night service 1 - 16 c.p. lamp in bed room;

Chemical Engine Company, 1 - 10 c.p. lamp all night service.

And the said company will install the said above mentioned arc lights at such time and at such places within the limits of said city as may be ordered by the common council of said city without cost to said city; provided, however, that when any of said lamps now installed or which may hereafter be installed shall be removed to another place in said city, by order of the common council of said city then the city shall pay the actual cost of such removal.

And the said company hereby binds itself to fully perform all the conditions of this offer on its part to be performed, as soon as the terms thereof shall have been accepted by

the proper authorities of said City of Albany.

has caused these presents to be signed by its President and
Secretary and its corporate seal to be affixed this 13th day
of November 1905.
