

## ORDINANCE NO. 524

Declaring a surplus on First Street Washington to Calapooia St

Ord 524

An Ordinance by declaring a surplus on account  
Declaring of Street paving by the Warren Construction Company, as  
a surplus per contract on First Street from the East Curb line  
on 1st from of Washington Street to the East Curb line of Calapooia  
Wash to Street in the City of Albany Oregon, and directing  
Calapooia the Recorder of said City of place to the credit of the  
Several owners of the various parcels of real  
estate abutting upon said portion of said First  
Street, heretofore assessed for making such  
improvement, and entered upon the Docket of  
City Line of said City of Albany their pro por-  
triate share of such surplus.

The People of the City of Albany do ordain as follows:-

Section 1. That a surplus of  $20\frac{3}{4}$  per cent is  
hereby declared and directed to exist upon  
the completion of the contract entered into by  
and between the City of Albany and the Warren  
Construction Company, for the improvement  
of First Street, from the East Curb line of  
Washington Street and the East Curb line  
of Calapooia Street in favor of each of the  
several owners of the various parcels of real  
estate abutting upon said portion of said First  
Street, heretofore assessed for making such  
improvement as their several interests  
may appear.

Section 2. The Recorder of the City of Albany  
is hereby directed to enter in the Docket of City  
Lines, in the surplus Column thereof, a credit  
of  $20\frac{3}{4}$  per cent based upon the several amounts  
hereto on assessed and entered therein to defray  
the cost of the improvement of said portion of  
said First Street, said surplus being in favor  
of the following named persons, owners of said  
various parcels of real estate, in the several  
amounts as follows, to-wit:

George L. Cannon & Pitts	- - -	\$318.45
John H. Simpson	- - -	238.84
Dr. J. L. Gill	- - -	79.61
