

An ordinance to ascertain and determine the probable cost of certain improvements which the council of the City of Albany, Oregon has determined in resolution No. 23, adopted by said council on the 26th day of June, 1912, to improve Second Street from the east curb line of Main Street to the west curb line of Harrison Street; to ascertain, assess, determine and declare the proportionate share of such probable cost of such improvement of said Second Street that is assessed upon each lot or part thereof adjacent to said part of Second Street to be so improved; to direct the recorder of said city to enter a statement of such assessment in the docket of City liens as provided by the charter of said city.

Whereas, on the 8th day of May 1912, the council of the City of Albany Oregon, on motion ordered the City Engineer of said city to make plans and specifications for the improvement of Second Street from the east curb line of Main Street to the west curb line of Harrison Street in said city by grading said street to the required curb grade and paving same, and for the estimates of the work to be done on the said portion of Second Street and the probable cost thereof, and

Whereas, the City Engineer of said City of Albany, pursuant to said Order made plans, specifications and estimates as directed by said order for the improvement of said Second Street in the manner specified in said Order and filed said plans, specifications and estimates in the Recorder's office in said city on the 14th day of June, 1912; and

Whereas, the said City Council on the 26th day of June, 1912 by resolution No. 23 duly adopted by said council determined and resolved that it deemed it expedient and that said council proposed to improve Second Street from the east curb line of Main Street to the west curb line of Harrison Street in the manner provided in said resolution No. 23; and

Whereas, in and by said resolution No. 23 adopted as aforesaid by the council, the City Recorder of said city was duly ordered and directed by said council to give notice of said proposed improvement of said Second Street from the east curb line of Main Street to the west curb line of Harrison Street as provided by the Charter of said City of Albany; and

Whereas, the City Recorder, in pursuance of said order and direction of the council of said city of Albany did duly give notice of said proposed improvement of said Second Street in the manner provided by the charter of said city; and

Whereas, the said council in and by said resolution No. 23 ascertained and determined the total probable cost of such

ing said improvement of said Second Street to be paid by the owners of the real property adjacent to said portion of said Second Street to be improved as mentioned in said resolution No. 23 to be the sum of \$607.05 and the total probable cost of making said improvement of said Second Street to be the sum of \$722.40.

Therefore,

The People of the City of Albany Do Ordain as Follows:

Section 1. That Second Street in the City of Albany, Oregon, from the east curb line of Main Street to the west curb line of Harrison Street shall be improved as follows:

First, By grading said street to the required subgrade.  
Second, By grading said street six inches deep in the center and three inches deep at the outer edges, twelve feet wide.

All in accordance with said resolution No. 23 and the plans and specifications, or said improvement filed by the City Engineer with the City Recorder of the said City of Albany, on the 24th day of June, 1912.

Section 2. That the probable cost of making said improvement of said Second Street in the City of Albany, Oregon, from the east curb line of Main Street to the west curb line of Harrison Street in the manner heretofore determined by the council of the said City of Albany in and by said resolution No. 23 is hereby declared to be the sum of \$722.40.

Section 3. That the proportionate share of said probable cost of said improvement of said Second Street assessed upon each lot or part thereof adjacent to said part of Second Street to be improved as aforesaid and as determined by said council and by said resolution No. 23, is hereby ascertained, and declared to be the sum set and placed immediately upon the separate description of each of such lots or parts thereof as follows:
