

Ordinance  
No. 609

An ordinance providing for the time and manner of improving Pine Street from the South side of Front Street to the North curb line of Duane Road, providing how the cost of such improvement shall be paid, the penalty or damages to the City of Albany by the person or persons making such improvement if the same shall not be completed within the time agreed upon, and the giving of a good and sufficient bond for the faithful performance of the work of such improvement of said part of said street and providing for the giving by the Recorder of said City of proper notice for bids for the completion of such improvement of said part of said street

The People of the City of Albany do Ordain as follows

Section 1. That Pine Street from the South line of Front Street to North curb line of Duane Road shall be improved in the following manner:

- First. By raising said street to the required sub-grade.
- Second. By graveling said street six inches deep in the center and three inches deep at the outer edge, twelve feet wide.

Said improvement to be made in accordance with the charter and ordinances of the City of Albany, Oregon, and the plans and specifications and estimates of the City Engineer of said City for the improvement of said Pine Street filed in the office of the City Recorder of said City on the 12th day of June, 1912.

The cost of said improvement of said portion of Pine Street at the crossings or intersections thereof by other streets shall be paid by the City of Albany out of the general fund of said city; the remaining portion of the cost of said improvement of said Second Street shall be paid out of the funds collected and arising upon and out of the assessment heretofore made, as claimed and determined by ordinance No. 608 passed the Council of the said City of Albany on the 19th day of August, 1912 and approved by the Mayor of said city on the 19th day of August, 1912, on the lots and parts of lots adjacent to said portion of said Second Street to be so improved and specified and particularly here fitted there by an official book of said City.

The improvement of said Pine Street shall be completed by the first day of November 1912.

All bids for the making of said improvement of said street deemed unreasonable by the Council of the City of Albany may be rejected.

Any firm, person or corporation with whom any contract may be entered into by the city for the making of said improvement shall be deemed to be making said improvement.

RECORDS, ALBANY, OREGON

at the time of signing such contract, make, execute and deliver to the city a good and sufficient bond with good and sufficient surety in the sum of Five hundred dollars for the faithful performance of such contract.

Section 2. If the firm, person or corporation entering into any contract with the said City of Albany to make said improvement of said Pine Street has not complied to the same within the time mentioned and specified in the said contract, said City shall be deemed to suffer damages on account thereof to the amount of \$2.50 per day for each and every day the completion of said work is delayed beyond the time stated in said contract, which amount shall be paid by such contractor doing the work at the completion thereof, unless the time of the completion of said improvement is extended by the council.

Section 3. The Recorder of the City of Albany is hereby ordered and directed to immediately give notice or vic for the making of said improvement of said portion of Pine Street, by publishing such notice ten days in the Albany Evening Herald, a daily newspaper published in the said City of Albany, fully describing in said notice the time and manner of doing the work of said improvement of said Record Street.
