An ordinance to amend Section 14 and to repeal Section 7 of Ordinance No. 636 entitled "An ordinance to enlarge the duties of the inspector of Plumbing of the City of Albany, to provide for the registration of persons, firms and corporations engaged in the installing of electric appliances and to regulate electric wiring in or on buildings, awnings and additions to any building, all within the limits of the City of Albany, Oregon, and providing a penalty for non-compliance" passed by Council May 16th, 1913, and approved May 2nd, 1913.

The Rec, to of the City of Albany Is Ordain As Follows:

Section 1. That Section 7 of Ordinance No. 636 entitled "An ordinance to enlarge the duties of the inspector of Plumbing of the City of Albany, to provide for the registration of persons, firms and corporations engaged in the installing of electric appliances and to regulate electric wiring in or on buildings, awnings and additions to any building, all within the limits of the City of Albany, Oregon, and providing a penalty for non-compliance" passed by Council May 16th, 1913, and approved May 2nd, 1913, be and the same is hereby amended to read as follows:

Section 1. There is hereby added to the duties of the Building Inspector the powers and duties of an Inspector of Electric Wiring and the same shall hereinafter be referred to as the Building Inspector, and he shall not be interested directly or indirectly in any firm doing electrical work subject to his inspection.

Section 2. That Section 14 of Ordinance No. 636, entitled "An ordinance to enlarge the duties of the inspector of Plumbing of the City of Albany, to provide for the registration of persons, firms and corporations engaged in the installing of electric appliances and to regulate electric wiring in or on buildings, awnings and additions to any building, all within the limits of the City of Albany, Oregon, and providing a penalty for non-compliance" passed by Council May 16th, 1913, and approved May 2nd, 1913, be and the same is hereby amended to read as follows:
