ORDINANCE NO. 239

AN ORDINANCE PROVIDING FOR THE TIME AND MARKER OF IMPROVING FIRST STREET FROM THE WEST CURS LIVE OF SHERMAY STREET TO THE EAST LIVE OF FINE STREET; PROVIDING HOW THE COST OF SUCH IMPROVEDENT SHALL SE PAID. THE PENALTY OF DAMAGE TO THE CITY OF ALBANY BY THE PERSON OR PERSONS MAKING SUCH IMPROVEDENT, IF THE SAME SHALL NOT BE COMFLETED WITHIN THE TIME AGREED UPON, AND THE GIVING OF A GOOD AND SUFFICIENT BOND FOR THE FAITHFUL PREFORMANCE OF THE WORK OF SUCH IMPROVEMENT OF SAID PART OF SAID STREET, AND PROVIDING FOR THE GIVING BY THE RECORDER OF SAID CITY OF PROPER NOTICE FOR BIDS FOR THE COMPLETION OF SUCH IMPROVEMENT OF SAID FART OF SAID STREET.

THE FROPLE OF THE CITY OF ALBANY DO OADAIN AS FOLLOWS:

Section 1. That First Street from the west curb line of Sherman Street to the east line of Pine Street in the City of Albany, Oregon, shall be improved in the following manner, to-wit:

First: Second: By grading sail street to the proper subgrade. By paying the roadway of said street full with with asphaltic concrete payement on an asphaltic concrete foundation.

Third: Fourth: By constructing inlets. By laying and constructing asphaltic concrete

headers.

Said improvement shall be made in accordance with the charter and ordinances of the City of Albany, Oregon, and the plans, specifications and estimates of the Acting City Engineer of said City, for the improvement of said Street, filed in the office of the Recorder of said City of Albany, Oregon, on the 23rd day of April, 1919, endorsed "Engineer's plans and specifications for the improvement of First Street from the west curb line of Sherman Street to the east line of Pine Street and the estimate of the work to be done on said street and the procable cost thereof."

The cost of said improvement of said portion of First Street shall be paid out of the funds collected and arising upon and out of the assessment hereafter to be made, ascertained and declared by the Council of the City of Albany on the lots and parts of lots adjacent to said portion of said First Street so to be improved and especially and particularly benefited thereby, as provided by the charter of said City.

The said improvement of said portion of said First Street shall be completed by the 15th day of October, 1919.

All bids for the making of said improvement of said street deemed un-

Any person, firm or corporation with whom any contract may be entered, into by the City for the making of said improvement shall, before commencing said improvement, and at the time of signing such contract, make, execute and deliver to said City a good and sufficient bond, with good and sufficient surety to be approved by the Mayor of said City, in the sum of Four Thousand Dollars for the faithful performance of such contract.

ORDINANCE NO. 332

Section 2. If the person, firm or corporation entering into any contract with the said City of Albany to make said improvement of said First Street shall not complete the same within the time mentioned and specified in said contract, said city shall be deemed to suffer damages on account thereof to the amount of \$25.00 per day for each and every day the completion of said work is delayed beyond the time stated in such contract, which amount shall be paid by such contractor doing the work at the completion thereof, unless the time of completion of said improvement is extended by the Council.

Section. 3. The Recorder of said city is hereby ordered and directed to give proper notice for bids for the making of such improvement of said portion of said First Street by publishing such notice ten days in the Albany Daily Democrat a daily newspaper published in said City of Albany, fully describing in said notice the time and manner of doing the work of said improvement of said First Street.
