

ORDINANCE NO. 270.

AN ORDINANCE declaring a surplus on account of the improvement by L. O. Herrold of Sixth Street from the West line of Washington Street to the East curb line of Elm Street in the City of Albany, Oregon, and directing the Recorder of the City of Albany to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed and entered of record in the Docket of City Liens in the City of Albany, Oregon, for making such improvement, their proportionate share of such surplus.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: That a surplus of 2.4 per cent is hereby ascertained and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon, and L. O. Herrold for the improvement of Sixth Street from the West line of Washington Street to the East curb line of Elm Street in the City of Albany, Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.

Section 2: The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens in the surplus column thereof a credit of 2.4 per cent, based upon the several amounts heretofore assessed and entered therein to defray the cost of improving said street; said surplus being in favor of the following named persons, owners, or reputed owners of such parcels of real estate and in the sums as follows, to-wit:
