

ORDINANCE NO. 1000

AN ORDINANCE DECLARING A SURPLUS ON ACCOUNT OF THE IMPROVEMENT BY BOOM & DAVIS OF PINE STREET FROM THE NORTH LINE OF EIGHTH STREET NORTH TO THE SOUTH LINE OF SANTIAM STREET, IN THE CITY OF ALBANY, OREGON AND DIRECTING THE RECORDER OF THE CITY OF ALBANY, OREGON AND DIRECTING THE RECORDER OF THE CITY OF ALBANY TO PLACE TO THE CREDIT OF THE SEVERAL OWNERS OF THE VARIOUS PARCELS OF REAL ESTATE ADJACENT TO SAID IMPROVEMENT, HERETOFORE ASSESSED AND ENTERED OF RECORD IN THE DOCKET OF CITY LIENS IN THE CITY OF ALBANY, OREGON FOR MAKING SUCH IMPROVEMENT, THEIR PROPORTIONATE SHARE OF SUCH SURPLUS.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$ 171.27 is hereby ascertained and declared to exist upon the completion of the contract entered into by and between the City of Albany, Oregon and Boom & Davis for the improvement of Pine Street from the North line of Eighth Street to the South line of Santiam Street, in the City of Albany Oregon, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for making such improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens in the surplus column thereof a credit in favor of the following named persons, owners and reputed owners of such parcels of real estate and in the sum as follows, to-wit:


