

ORDINANCE NO. 1205

AN ORDINANCE TO ASCERTAIN, DETERMINE AND DECLARE A DEFICIT ON ACCOUNT OF THE IMPROVEMENT BY BOOM & DAVIS OF SEVENTH STREET FROM THE EAST LINE OF MAIN STREET TO THE WEST LINE OF PINE STREET IN THE CITY OF ALBANY, OREGON, AND TO ASCERTAIN, REASSESS, DETERMINE AND DECLARE THE PROPORTIONATE SHARE OF SUCH DEFICIT THAT IS REASSESSED UPON EACH LOT, OR PART THEREOF, ADJACENT TO SAID SEVENTH STREET AND TO DIRECT THE RECORDER OF THE CITY OF ALBANY TO ENTER SUCH DEFICIT SO LEVIED IN THE DOCKET OF THE CITY LIENS AS PROVIDED BY THE CHARTER OF SAID CITY.

WHEREAS, ON THE 27TH DAY OF APRIL, 1921, THE COUNCIL OF THE CITY OF THE CITY OF ALBANY PASSED ORDINANCE NO. 986, ASSESSING UPON LOTS, AND PARTS THEREOF, ADJACENT TO SAID SEVENTH STREET, CERTAIN AMOUNTS FOR THE IMPROVEMENT OF SAID SEVENTH STREET; AND

WHEREAS, THE SAID IMPROVEMENT HAS BEEN COMPLETED AND THE CONTRACTORS FINAL FIGURES HAVE BEEN FILED IN THE OFFICE OF THE RECORDER OF THE CITY OF ALBANY, AND THE CITY COUNCIL HAS SETTLED WITH THE CONTRACTORS FOR SAID IMPROVEMENT.

WHEREAS, IT IS FOUND BY THE COUNCIL THAT THE SUMS ASSESSED IN SAID ORDINANCE UPON THE SEPARATE LOTS, OR PARTS THEREOF ADJACENT TO SAID SEVENTH STREET, AS DIRECTED IN SAID ORDINANCE NO. 986 AND EACH OF THEM IS INSUFFICIENT TO DEFRAY THE COST OF SAID IMPROVEMENT, AND THE TOTAL ASSESSMENT AS ASCERTAINED, ASSESSED, DETERMINED AND DECLARED BY SAID ORDINANCE NO. 986 IS INSUFFICIENT TO PAY THE COST OF SAID IMPROVEMENT BY THE SUM OF \$ 50.02, AND THAT IT IS NECESSARY TO REASSESS THE SAID REAL PROPERTY.

T H E R E F O R E

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. The Council hereby ascertains, determines and declares that there is a deficit made in said Ordinance No. 986 as against the lots and parts of lots adjacent to said Seventh Street in the sum of \$ 50.02, and that there be and is hereby reassessed the same to be in excess of the original assessment against the several parcels of land, whose owners, or reputed owners, together with the description of the property assessed, as owned by each of them respectively, with the amount of such assessment charged to each of them respectively, in as follows:


