

**ORDINANCE NO. 1193**

AN ORDINANCE to ascertain and determine the probable cost of certain improvements which the Council of the City of Albany, Oregon, has determined to make in resolution No. 16 adopted by said Council on the 27th day of May, 1925, on Denver Street, from the north curb line of Eighth Street to the south curb line of Santiam Road, in the City of Albany, Oregon; to ascertain, assess, determine and declare the proportionate share of such probable cost of such improvement of said portion of said Street that is assessed upon each lot, or part thereof, adjacent to said portion of Denver Street to be so improved; to authorize and direct the Recorder of said City to enter a statement of such assessment in the docket of City Liens, as provided by the Charter of said City; and declaring an emergency:

WHEREAS, on the 23th day of May, 1925, the Council of the City of Albany, Oregon, duly adopted a resolution requiring Charles H. Leonard, Engineer, to compile and file in the office of the Recorder of the said City on the 27th day of May, 1925, plans, specifications and estimates of the probable cost of making the improvement of Denver Street in said City from the north curb line of Eighth Street to the south curb line of Santiam Road, by grading and graveling the same; and

WHEREAS, said Engineer pursuant to said resolution, made plans, specifications and estimates as directed thereby for the improvement of said Denver Street, and file d the same in the office of the Recorder of said City on the 27th day of May, 1925, and

WHEREAS, the Council of the said City on the 27th day of May, 1925, by Resolution No. 16, duly adopted by said Council, determined and resolved that it deemed it expedient, and that the Council proposed to improve Denver Street from the north curb line of Eighth Street to the south curb line of Santiam Road in said City of Albany, Oregon, in the manner provided in said resolution No. 16, and

WHEREAS, and by said Resolution No. 16 the Recorder of the City was duly ordered and directed to give notice of said proposed improvement of said Denver Street from the north curb line of Eighth Street to the south curb line of Santiam Road, as provided by the charter and ordinances of said City, and

WHEREAS, the Recorder in pursuance of said order and direction of the Council, did duly give notice of said proposed improvement of said Denver Street in the manner provided by said resolution, and the charter and ordinances of said City, and

WHEREAS, the said Council in and by said resolution No. 16 ascertained and determined the total probable cost of making said improvement of said Denver Street to be paid by the owners of real property adjacent to said portion of said Street to be improved as specified in said resolution No. 16, to be the sum of SIX HUNDRED THIRTY-SIX and 66/100 Dollars (\$636.66); and

WHEREAS, by ordinance No. 1189, after due notice of the time and in the manner provided by law, the bid of U.G. Hayne for the making of said improvement of said portion of Denver Street, was accepted, and the Mayor and Recorder of the City of Albany were thereby authorized to enter into a contract with U.G. Hayne for the making of said improvement in accordance with said bid, by grading and graveling said portion of said Street, and in other respects in accordance with said Resolution No. 16.

**THEREFORE  
THE PEOPLE OF THE CITY OF ALBANY, OREGON, DO ORDAIN AS FOLLOWS:**

Section 1. That Denver Street in the City of Albany, Oregon, from the north curb line of Eighth Street to the south curb line of Santiam Road, shall be improved as follows:

- 1st: By grading the street to the proper sub-grade;
- 2nd: By surfacing the roadway of said street 12 feet wide with gravel;
- 3rd: By laying sub-drain tile.

All in accordance with said resolution No. 16, and the plans and specifications for said improvement filed by Charles H. Leonard, City Engineer, with the Recorder of the City of Albany, Oregon, on the 27th day of May, 1925.

Section 2. That the probable cost of making said improvement of said Denver Street, from the north curb line of Eighth Street to the south curb line of Santiam Road in said City of Albany, Oregon, in the manner heretofore determined by the Council, and in and by said resolution No. 16, to be paid by the owners of real property adjacent to said portion of Denver Street, is hereby declared to be the sum of SIX HUNDRED THIRTY-SIX and 66/100 DOLLARS (\$636.66).

Section 3. That the proportionate share of said probable cost of said improvement of said Denver Street assessed upon each lot, or part thereof, adjacent to said portion of Denver Street to be improved as aforesaid, and as determined by said Council in and by said resolution No. 16, is hereby ascertained and declared to be the sum set and placed immediately after the separate description of each of such lots, or parts thereof, as follows:


