

ORDINANCE No. 1217.

AN ORDINANCE to ascertain and declare the deficit existing on account of the improvement by U.G.Hayne, of Sherman Street from the south property line of Water Street to the north property line of First Street, in the City of Albany, Oregon, and to assess, ascertain, and determine and declare the proportionate share of such deficit upon each lot, or part thereof, adjacent to said portion of said Street, and to authorize and direct the Recorder of said City to enter a statement of such deficit and reassessment in excess of the original assessment heretofore made, apportioning such excess equitably to the various lots or parts thereof, especially and particularly benefited by such improvement, in the docket of City Liens, as provided by the charter of said City.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS;

Section 1. That a deficit of \$45.22 is hereby ascertained and declared to exist upon the completion of the contract entered into between the City of Albany, Oregon, and U.G.Hayne for the improvement of Sherman Street, from the south property line of Water Street to the north property line of First Street in said City.

Section 2. That the proportionate share of said deficit hereby ascertained and declared to exist upon the completion of said improvement of said portion of Sherman Street is hereby assessed upon each lot, or part thereof, adjacent to said portion of said Sherman Street improved as aforesaid, in the sum set and placed immediately after the separate description of each of such lots, or parts thereof, as follows, to-wit:

<u>E.W. and Millie Fugua.</u> --Lot 5 in Block 3 in Hackleman's Third Addition to the City of Albany, Linn County, Oregon,	Deficit	\$11.31
<u>John W. Hamel.</u> --Lot 4 in Block 3 in Hackleman's Third Addition to the City of Albany, Linn County, Oregon,	Deficit	11.30
<u>M.L.Gade.</u> --The north $\frac{1}{2}$ of Lot 1 in Block 8 in Hackleman's Third Addition to the City of Albany, Linn County, Oregon,	Deficit	5.66
<u>F.W.Marah.</u> --The south $\frac{1}{2}$ of Lot 1 in Block 8 in Hackleman's Third Addition to the City of Albany, Linn County, Oregon,	Deficit	5.65
<u>James and Mattie Thompson.</u> --Lot 8 in Block 8 in Hackleman's Third Addition to the City of Albany, Linn County, Oregon,	Deficit	11.30

Section 3. The Recorder of the City of Albany is hereby ordered and directed to immediately enter a statement of the reassessment of such deficit hereby made and declared by this ordinance opposite the names of the respective owners of each lot or part thereof, hereinabove described, in the Docket of City Liens of the City of Albany, Oregon, in accordance with the provisions of the charter of said City.
