

ORDINANCE No. 1253

AN ORDINANCE declaring a surplus on account of the construction of a lateral sewer by Yunker, Wiecks & Co., beginning at the manhole in the Geary Street Trunk Sewer, which is 13 feet easterly from the southeast corner of lot 5 in block 13 in Hackleman's 4th Addition to the City of Albany, Oregon; thence running westerly through the center of Blocks 13 and 13 in said Addition, a distance of 632 feet to the southwest corner of lot 1 in Block 13 in said Hackleman's Fourth Addition; and directing the Recorder to place to the credit of the several owners of the various parcels of real estate adjacent to said improvement, heretofore assessed and entered of record in the Docket of City Liens of the City of Albany, Oregon, for the making of such improvement, their proportionate share of such surplus:

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That a surplus of \$26.34 is hereby ascertained and declared to exist upon the completion of the contract heretofore entered into by and between the City of Albany, Oregon, and Yunker, Wiecks & Co. for the construction of a lateral sewer beginning at the manhole in the Geary Street trunk sewer, which is 13 feet easterly from the southeast corner of lot 5 in block 13 in Hackleman's Fourth Addition to the City of Albany, Oregon, thence running westerly through the center of Blocks 13 and 13 in said Hackleman's Fourth Addition a distance of 632 feet to the southwest corner of ~~block~~ lot 1 in block 13 in said Hackleman's Fourth Addition, and in favor of the several owners of the various parcels of real estate adjacent to said improvement heretofore assessed for the making of said improvement.

Section 2. The Recorder of the City of Albany is hereby directed to enter in the Docket of City Liens of said City, in the surplus column thereof, the sum of \$26.34, based upon the several amounts heretofore assessed for making such improvement and entered therein to defray the cost of the construction of said lateral sewer, said surplus being in favor of the various owners, or reputed owners, of the various parcels of real estate, and in the following sums, to-wit:
