

ORDINANCE NO. 1318

AN ORDINANCE to authorize the Council of the City of Albany, Oregon, to purchase of Loggers and Contractors Machinery Company, a corporation, one No. 4 Russell Motor Patrol; to sell and deliver to said Loggers and Contractors Machinery Company, as part payment therefor, the Fordson Tractor now owned by said City; to appropriate the sum of Two Thousand Four Hundred Ninety-Nine and 83/100 Dollars (\$2,499.83) of the Street Funds of said City in payment of the balance of the purchase price thereof; and to authorize and direct the Recorder to issue and deliver to said Loggers and Contractors Machinery Company a warrant on the Street Funds of said City for said amount.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. The Council of the City of Albany, Oregon, is hereby authorized to purchase of Loggers and Contractors Machinery Company, a corporation, one No. 4 Russell Motor Patrol and for the sum of Two Thousand Nine Hundred Ninety-Nine and 83/100 Dollars (\$2,999.83) f.o.b. cars Albany, Oregon, and in payment thereof the Council is hereby authorized and directed to deliver to said Loggers and Contractors Machinery Company the Fordson tractor now owned by said City, for which said tractor the said Loggers and Contractors Machinery Company shall give said City credit in the sum of Five Hundred Dollars (\$500.00) on the purchase price of said motor patrol.

Section 2. That there be and is hereby appropriated from the street funds of said city the sum of Two Thousand Four Hundred Ninety-Nine and 83/100 Dollars (\$2,499.83) for the purpose of providing funds to make payment of the balance of the purchase price of the Russell Motor Patrol described in Section 1 hereof.

Section 3. The Recorder of the City of Albany, Oregon, is hereby authorized and directed to issue and deliver to Loggers and Contractors Machinery Company, a corporation, a warrant drawn on the Street Funds of said City of Albany in the sum of Two Thousand Four Hundred Ninety-Nine and 83/100 Dollars (\$2,499.83) in full payment of the balance of the purchase price of the Russell Motor Patrol heretofore described.

Section 4. That the purchase of said motor patrol, as hereinabove provided, shall be in accordance with the proposal, and subject to the general warranty of said Loggers and Contractors Machinery Company, as set forth in that certain written communication of said Loggers and Contractors Machinery Company dated June 10th, 1929, and now on file with the Recorder of said City.


