THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. That Ordinance No. 10, entitled "An ordinance relating to letting contracts by the City," passed by the common council of said City on February 26, 1873, and approved by the mayor on the same day, be and the same is, hereby repealed.

Section 2. That Ordinance No. 19, entitled "An ordinance in relation to cordwood," passed by the common council of said city Enacted May 27, 1873, and approved by the mayor on the same day, be, and the same is, hereby repealed.

Section 3. That Ordinance No. 22, entitled "An ordinance relating to and describing the seal of the city of Albany," passed by the common council of said city on May 27, 1873, and approved by the mayor on the same day, be, and the same is hereby repealed.

Section 4. That Ordinance No. 29, entitled "An ordinance relating to removing dead animals from the City of Albany," passed by the common council of said city on April 14, 1874, and approved by the mayor on the same day, be, and the same is, hereby repealed.

Section 5. That Ordinance No. 136, entitled "An ordinance relating to city elections and the city organization and manner of conducting elections," passed by the common council of said city on May 12, 1885, and approved by the mayor on May 13, 1885, be, and the same is, hereby repealed.

Section 6. That Ordinance No. 141 entitled "An ordinance to license tax and regulate certain calling trades and employments, and to provide for the manner of issuing licenses," passed by the common council of said city on February 9, 1886, and approved by the mayor on February 10, 1886, be, and the same is, hereby repealed.

Section 7. That Ordinance No. 160, entitled "An ordinance defining and prescribing the qualifications and duties of the city marshal," passed by the common council of said city on August 16, 1887, and approved by the mayor August 23, 1887, be, and the same is, hereby repealed.

Section 8. That Ordinance No. 162, entitled "An ordinance to regulate and prescribe the qualifications, duties and compensation of the city recorder of the city of Albany," passed by the common council of said city on August 16, 1887, and approved by the mayor on August 25, 1887, be, and the same is, hereby repealed.

Section 9. That Ordinance No. 165, entitled "An ordinance providing for the appointment of day and night police; prescribing their duties, rules and regulations for their government, and the mode and manner of their trial, and suspension or removal," passed by the common council of said city on September 13, 1887, and approved by the mayor September 19, 1887, be, and the same is hereby repealed.

Section 10. That Ordinance No. 183, entitled "An ordinance to regulate the running of rail road cars, rail-road trains and locomotives and to prohibit persons, other than employees from climbing upon, boarding or entering said road cars at any places other than the regular depot," passed by the common council of said city on November 13, 1888, and approved by the mayor on November 14, 1888, be, and the same is, hereby repealed.

Section 11. That Ordinance No. 187, entitled "An ordinance for the protection of fire hose, and to prevent obstructing the streets during a fire," passed by the common council of said city on May 15, 1889, and approved by the mayor on May 17, 1889, be, and the same is, hereby repealed.

Section 12. That Ordinance No. 205, entitled "An ordinance to declare any person guilty of a misdemeanor who shall suffer any poultry to run at large within the limits of the City of Albany, and to provide a punishment for such offense, and to define what shall be deemed a running at large of poultry," passed by the common council of said city on March 30, 1891, and approved by the mayor on April 3, 1891, be, and the same is, hereby repealed.

Section 13. That Ordinance No. 207, entitled "An ordinance declaring it to be a misdemeanor for any person or persons to keep any hog or hogs within the limits of the City of Albany, and to provide a punishment for such offense," passed by the common council of said city on April 14, 1891, and approved by the mayor on April 16, 1891, be, and the same is, hereby repealed.

ORDINANCE NO. 1507

Section 14. That Ordinance No. 208, entitled, "An ordinance relating to certain animals running at large within the limits of the city of Albany, and providing for the taking up, impounding and selling of all such animals, when found so running in said city, and to define what shall constitute a running at large of any such animals insaid city, to regulate the driving of such animals through the streets and alleys thereof, and to provide for the election of Poundmanster and regulate his fees and duties," passed by the common council of said city on April 14, 1891, and approved by the mayor on April 16, 1891, be, and the same is, hereby repealed.

Section 15. That Ordinance No. 276, entitled "An ordinance to amend Section (3) three, and Section (5) five of Ordinance No. 141, entitled, "An ordinance to license, tax, and regulate certain callings, trades, and employments, and to provide for the manner of issuing licenssss," passed by the council, February 9, 1886, and approved by the mayor February 10, 1886," passed by the common council of said city on January 23, 1894, and approved by the mayor on January 26, 1894, be, and the same is, hereby repealed.

Section 16. That Ordinance No. 293, entitled "An ordinance providing for the material to be used in and the manner of constructing sidewalks, crosswalks and curbs," passed by the common council of said city on August 13, 1895, and approved by the mayor on August 17, 1895, be, and the same is, hereby repealed.

Section 17. That Ordinance No. 295, entitled, "A bill for an ordinance providing for the material to be used in, and the manner of constructing sidewalks on First Street, between Ferry Street, and Ellsworth Street, in the city of Albany, Oregon," passed by the common council of said city on September 10, 1895, and approved by the mayor on September 12, 1895, be, and the same is, hereby repealed.

Section 18. That Ordinance No. 304, entitled "An ordinance to provide for an assessment, and levy, and collect tax thereon, for street, and road work, within the city of Albany, Oregon, and to provide for the manner of collecting the same, and to provide for the manner of doing the work upon the streets, and roads in said city," passed by the common council of said city on February 11, 1896, and approved by the mayor on February 17th, 1896, be, and the same is, hereby repealed.

Section 19. That Ordinance No. 323, entitled "An ordinance to amend ordinance No. 317, entitled "An ordinance to license, tax and regulate billiard rooms, and pool rooms, and to repeal so much of Section 14, of ordinance No. 141, entitled "An ordinance to license, tax, and regulate certain callings, and employments, and to provide for the manner of issuing licenses," "approved Feb'y 10, 1886," as relates to billiard, and pool rooms, "Approved March 26, 1897," passed by the common council of said city on (NO DATE) and approved by the mayor on May 14, 1898, be and the same is, hereby repealed.

Section 20. That Ordinance No. 328, entitled "An ordinance to regulate the use of water from the water works, during the time of fire," passed by the common council of said city on (NO DATE) and approved by the mayor on September 16, 1898, be, and the same is, hereby repealed.

Section 21. That Ordinance No. 348, entitled "An ordinance to amend Section 11 of an ordinance entitled, "An ordinance to license, tax and regulate certain callings, trades and employments and to provide for the manner of issuing license, approved February 10, 1886," passed by the common council of said city on (No date) and approved by the mayor on May 31, 1901, be, and the same is, hereby repealed.

Section 22. That Ordinance No. 380, entitled "An ordinance to protect the fire alarm system and the fire apparatus of the City of Albany, Oregon, and providing punishment for violation thereof," passed by the common council of said city on (No date) and approved by the mayor on December 23, 1903, be, and the same is, hereby repealed.

Section 23. That Ordinance No. 389, entitled "An ordinance prohibiting the maintaining, operating, or playing of nickel-in-the-slot machines or other devices of like character and to provide a punishment for the violation thereof," passed by the common council of said city on (No date) and approved by the mayor on February 10, 1904, be, and the same is, hereby repealed.

Section 24. That Ordinance No. 388, entitled "An ordinance to provide for the prevention of obstructions of streets and alleys and other public places, and matters kindred thereto, within the corporate limits of the city of Albany, and to provide a punishment for the violation thereof," passed by the common council of said city on (No date) and approved by the mayor on March 23, 1904, be, and the same is, hereby repealed.

Section 25. That Ordinance No. 415 entitled "An ordinance changing the curb line on both sides of Montgomery Street in the City of Albany," passed by the common council of said city (No date) and approved by the mayor on March 31, 1906, be, and the same is, hereby repealed.

Section 26. That Ordinance No. 417, entitled "An ordinance to provide for the prevention of fires and the protection of persons and property endangered thereby; and to establish and define the fire limits of the City of Albany; and to repeal all ordinances and parts of ordinances in conflict therewith," passed by the common council of said city on (No date) and approved by the mayor on May 24, 1906, be, and the same is, hereby repealed.

Section 27. That Ordinance No. 425, entitled "An ordinance to license, tax, and regulate skating rinks, and to repeal section twenty one (21) of ordinance No. 141, entitled "An ordinance to license, tax and regulate certain callings, trades and employments and to provide for the manner of issuing licenses," approved, February 10, 1886, " passed by the common council of said city on May 14, 1907, and approved by the mayor on May 14, 1907, be, and the same is hereby repealed.

Section 28. That Ordinance No. 439, entitled "An ordinance to amend Section 2 of Ordinance No. 417, entitled "An ordinance to provide for the prevention of fires and the protection of persons and property endangered thereby; and to establish and define the fire limits of the city of Albany; and to repeal all ordinances and parts of Ordinances in conflict therewith" passed by the council May 22, 1906, approved by the Mayor May 24, 1906," passed by the common council of said city on (No date) and approved by the mayor on March 26, 1908, be, and the same is hereby repealed.

Section 29. That Ordinance No. 466, entitled "An ordinance to punish any person, firm or corporation by fine for constructing, or allowing to remain that has been heretofore constructed, any barbed wire fence within the limits of the city of Albany, Oregon," passed by the common council of said city on (No date) and approved by the mayor on October 28, 1908, be, and the same is, hereby repealed.

Section 30. That Ordinance No. 468, entitled "An ordinance relating to the construction of sidewalks and curbing within certain limits in the city of Albany, and repealing all ordinances and parts of ordinances in conflict herewith," passed by the common council of said city on (no date) and approved by the mayor on November 11, 1908, be, and the same is, hereby repealed.

Section 31. That Ordinance No. 547, entitled "An ordinance amending Section 13 of Ordinance No. 141, entitled, "An ordinance to tax and regulate certain callings, trades and employments, and to provide for the manner of issuing licenses," passed by the council February 9, 1886, and approved February 10, 1886," passed by the common council of said city on June 16, 1911, and approved by the mayor on June 17, 1911, be, and the same is, hereby repealed.

Section 32. That Ordinance No. 577, entitled "An ordinance providing for the removal of grass and weeds from the streets and private property in the city of Albany, Oregon, and providing a penalty for violation hereof," passed by the common council of said city on April 12, 1912, and approved by the mayor on April 15, 1912, be, and the same is, hereby repealed.

Section 33. That Ordinance No. 625, entitled "An ordinance fixing the salary of the night policeman of the city of Albany, Oregon, and repealing all ordinance and parts of ordinances in conflict therewith," passed by the common council of said city on November 27, 1912, and approved by the mayor November 29, 1912, be, and the same is, hereby repealed.

Section 34. That Ordinance No. 628, entitled "An ordinance to amend Section 1 of Ordinance No. 417, entitled "An ordinance to provide for the prevention of fires and the protection of persons and property endangered thereby; and to establish and define the fire limits of the City of Albany; and to repeal all ordinances in conflict therewith" passed the council of said city on the 22nd day of May, 1906, and approved by the mayor May 24, 1906," passed by the common council of said city on March 12, 1913, and approved by the mayor on the same day, be, and the same is hereby repealed.

Section 35. That Ordinance No. 657, entitled, "An ordinance to amend Section 9 of Ordinance No. 468, entitled "An ordinance relating to the construction of sidewalks and curbing within certain limits in the City of Albany and repealing all ordinances and parts of ordinances in conflict herewith," passed by the council November 10, 1908, approved by the Mayor November 11, 1908," passed by the common council of said city on July 23, 1913, and approved by the mayor on the same day, be, and the same is, hereby repealed.

Section 36. That Ordinance No. 658, entitled "An ordinance to amend Section 1 of Ordinance No. 183, entitled "An ordinance to regulate the running of railroad cars, railroad trains and locomotives, and to prohibit persons, other than employees from climbing upon, or entering said railroad cars at any places other than the regular depot," passed the council November 12, 1888, approved November 14, 1888," passed by the common council of said city on July 23, 1913, and approved by the mayor on the same day, be, and the same is, hereby repealed.

Section 37. That Ordinance No. 698, entitled "An ordinance creating and regulating the fire department of the City of Albany," passed by the common council of said city on October 26, 1913, and approved by the mayor on the same day, be, and the same is, hereby repealed.

Section 38. That Ordinance No. 699, entitled "An ordinance to regulate the fire department of the City of Albany and repeal all acts and parts of acts in conflict therewith," passed by the common council of said city on Dec. 10, 1913, and approved by the mayor on the same day, be, and the same is, hereby repealed.

Section 40. That Ordinance No. 707, entitled "An ordinance to amend Section Four of Ordinance No. 468, entitled "An ordinance relating to the construction of sidewalks and curbing within certain limits in the City of Albany and repealing all ordinances and parts of ordinances in conflict herewith," passed by the council November 10, 1908, approved by the Mayor November 11, 1908, and amended by Ordinance No. 619," passed by the common council of said city on January 28th, 1914, and approved by the mayor on February 3rd, 1914, be, and the same is, hereby repealed.

Section 41. That Ordinance No. 710, entitled "An ordinance making it unlawful to permit card playing, dice throwing or other game of chance in any public place in the City of Albany and making it unlawful for any person to play cards, throw dice, or other game of chance in a public place in the City of Albany, providing what shall be deemed playing cards and providing a penalty for violation thereof," passed by the common council of said city on February 25, 1914, and approved by the mayor on February 27, 1914, be, and the same is, hereby repealed.

Section 42. That Ordinance No. 716, entitled "An ordinance regulating the sale of tobacco to minors and the use of tobacco by minors within the city of Albany and providing a penalty for violation thereof," passed by the common council of said city on March 11, 1914, and approved by the mayor March 17, 1914, be, and the same is, hereby repealed.

Section 43. That Ordinance No. 728, entitled "An ordinance to amend Section Nine of Ordinance No. 468, entitled "An ordinance relating to the construction of sidewalks and curbing within certain limits of the city of Albany and repealing all ordinances and parts of ordinances in conflict herewith" passed the council November 10, 1908, approved November 11, 1908, as said section is amended by Ordinance No. 657, passed the council July 23, 1913, approved July 23, 1913," passed by the common council of said city on June 10, 1914, and approved by the mayor on June 11, 1914, be, and the same is, hereby repealed.

Section 44. That Ordinance No. 743, entitled "An ordinance to amend Section 1 of Ordinance No. 136, of the City of Albany, entitled "An ordinance relating to city elections and the city organization and manner of conducting elections," passed the council May 12, 1885," approved May 13, 1885," passed by the common council of said city on August 26, 1914, and approved by the mayor on August 27, 1914, be, and the same is, hereby repealed.

Section 45. That Ordinance No. 829, entitled "An ordinance regulating the making of flying switches and the kicking of cars and providing a penalty for the violation thereof," passed by the common council of said city on August 11, 1915, and approved by the mayor on the same day, be, and the same is, hereby repealed.

Section 46. That Ordinance No. 838, entitled "An ordinance to license, tax and regulate fortune-telling, clairvoyance, palmistry and handreading and providing a penalty for the violation thereof," passed by the common council of said city on October 27, 1915, over the vote of the mayor, be, and the same is, hereby repealed.

Section 47. That Ordinance No. 859, entitled "An ordinance to amend Section 1 of Ordinance No. 628 entitled, "An ordinance to amend Section 1 of Ordinance No. 417, entitled, "An ordinance to provide for the prevention of fires and the protection of persons and property endangered thereby; and to establish and define the fire limits of the City of Albany; and to repeal all ordinances in conflict therewith," passed by the council of said city on the 22 day of May, 1906, and approved by the mayor May 24, 1906," passed by the council March 12th, 1913, and approved by the mayor March 12, 1913," passed by the common council of said city on April 12, 1916, and approved by the mayor on April 17, 1916, be, and the same is, hereby repealed.

Section 53. That Ordinance No. 908, entitled "An ordinance to amend Ordinance No. 884, entitled, "An ordinance to license, tax and regulate vehicles and hauling in the City of Albany, Oregon, and to provide a penalty for violation thereof," passed by the council December 27, 1916, and approved by the mayor December 27th, 1916," passed by the common council of said city on September 26, 1917, and approved by the mayor on the same day, be, and the same is, hereby repealed.

Section 54. That Ordinance No. 909, entitled "An ordinance to regulate the running of locomotives railroad trains, electric cars and electric trains within the corporate limits of the city of Albany, Oregon, and providing a penalty for violation thereof," passed by the common council of said city on September 26, 1917, and approved by the mayor on the same day, be, and the same is, hereby repealed.

Section 55. That Ordinance No. 921, entitled, "An ordinance to amend Section 5 of Ordinance Number 699 of the City of Albany, Oregon, entitled, "An ordinance to regulate the fire department of the City of Albany and repeal all acts and parts of acts in conflict therewith," passed by the council of said city December 10th, 1913, and approved December 10th, 1913, and to repeal all ordinances and parts of ordinances in conflict therewith," passed by the common council of said city on April 24, 1918, and approved by the mayor on April 25, 1918, be, and the same is, hereby repealed.

Section 56. That Ordinance No. 940, entitled "An ordinance creating a board of park commissioners, providing for appointment, filling of vacancies, and the organization and powers of said commission," passed by the common council of said city on May 28, 1919, and approved by the mayor on the same day, be, and the same is, hereby repealed.

Section 57. That Ordinance No. 957, entitled "An ordinance to amend Section 7 of an ordinance entitled "An ordinance creating and regulating the fire department of the city of Albany," passed by the Council April 22, 1914, and approved by the mayor April 25, 1914," passed by the common council of said city on December 23, 1919, and approved by the mayor on the same day, be, and the same is, hereby repealed.

Section 58. That Ordinance No. 958, entitled "An ordinance to amend Section 1 of Ordinance No. 136, entitled: "An ordinance relating to city elections and the city organization and manner of conducting elections," passed by the council May 12, 1885, and approved by the mayor May 13, 1885, as amended by Ordinance No. 743," passed by the common council of said city on February 25, 1920, and approved by the mayor on the same day, be, and the same is, hereby repealed.

Section 59. That Ordinance No. 973, the title, content, and date of passage of which is unknown, be, and the same is, hereby repealed.

Section 62. That Ordinance No. 993 entitled "An ordinance to establish and define the fire limits of the City of Albany, Oregon, and to repeal Ordinance No. 893, passed by the council on the 6th day of June, 1917, and approved by the mayor on the 6th day of June, 1917," passed by the common council of said city on June 22, 1921, and approved by the mayor on June 23, 1921, be, and the same is, hereby repealed.

Section 63. That Ordinance No. 1053, entitled "A bill for an ordinance fixing the salaries of certain officers of the city of Albany and providing the time for the payment thereof from and after the first day of January, 1923," passed by the common council of said city on October 25, 1922, and approved by the mayor on (No date), be, and the same is, hereby repealed.

Section 64. That Ordinance No. 1070, entitled "A bill for an ordinance concerning the display of fruits, vegetables and other merchandise upon the sidewalks in the city of Albany and providing a penalty for the violation thereof," passed by the common council of said city on May 23, 1923, and approved by the mayor on May 24, 1923, be, and the same is, hereby repealed.

Section 65. That Ordinance No. 1072 entitled "A bill for an ordinance to amend Section 8 of Ordinance No. 141, entitled "An ordinance to license, tax and regulate certain callings, trades and employments and to provide for the manner of issuing licenses," passed by the council February 9th, 1866, and approved by the mayor, February 10th, 1866, and providing a penalty for the violation thereof," passed by the common council of said city on May 23, 1923, and approved by the mayor on May 24, 1923, be, and the same is, hereby repealed.

Section 66. That Ordinance No. 1109 entitled "A bill for an ordinance relating to the posting of signs, bills, poster, or other advertising matter on buildings, posts, trees or other premises in the city of Albany, Oregon, and providing a penalty for the violation thereof and repealing Ordinance No. 889, entitled "An ordinance relating to the posting of signs, bills, posters or other advertising matter on buildings, posts, trees or other premises in the city of Albany, Oregon," passed by the council, May 9, 1917, and approved by the mayor May 9, 1917," passed by the common council of said city on December 28, 1923, and approved by the mayor on the same day, be, and the same is, hereby repealed.

Section 67.
