

ORDINANCE NO. 3060

AN ORDINANCE ELECTING TO DISPENSE WITH AN ELECTION WITHIN THE CITY OF ALBANY, OREGON, UNDER THE PROVISIONS OF SECTION 222.110 ORS, REGARDING THE ANNEXATION OF AN AREA SOUTH OF LEHIGH ACRES SUBDIVISION CONTIGUOUS TO THE CITY OF ALBANY, SETTING A TIME FOR PUBLIC HEARING ON THE SAME AND DECLARING AN EMERGENCY.

WHEREAS, more than two-thirds of the owners of the property and more than two-thirds of the total area which is the subject matter of this annexation have petitioned and requested the City of Albany to annex the area herein-after described to the City and the same being contiguous and in all respects qualifying under present statutes for annexation, and

WHEREAS, it is in the best interest of the City of Albany that a public hearing be held at the earliest possible date to consider objections to the annexation of the property herein described.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: DESCRIPTION OF PROPERTY

That an election within the City of Albany regarding the annexation of the following described property to-wit:

Beginning at the intersection of the W. line of U. S. Interstate 5 Freeway and the S. line of Lot 8, Block 3, Lehigh Acres Subdivision; thence S. 324.5 feet; thence S. 88°27' W. 981 feet, more or less, to SE corner of Blk 4, vacated Gerig Subdivision; thence S. 88°36' W. 675 feet; thence N. 1°23' W 782 feet, more or less, to a point S. 88° 37' W. 94 feet & S. 62°49' W. 55.61 feet from SW Corner Lot 14, Blk 1, Lehigh Acres Subdivision; thence N. 88°37' E. 94 feet; thence N. 62° 49' East 55.61 feet to SW corner Lot 14, Blk 1, Lehigh Acres Sub-division; thence S. 56°39' E. 254.31 feet; thence S. 69°26' E. 947.12 feet to SW corner Lot 11, Block 2, Lehigh Acres Subdivision; thence S. 82°50' E. 89.21 feet; thence N. 5°24' E. 29.60 feet; thence N. 88°21' E. 325 feet to point of beginning.

Section 2: HEARING


That there shall be a public hearing as to the advisability of annexing the property described in Section 1, to the City of Albany, on the 26th day of June, 1963, at 7:15 p.m. o'clock, and the City Recorder is hereby directed to give notice of said public hearing by publishing in a newspaper of general circulation, published in the said city once a week for two (2) successive and consecutive weeks and by posting in four (4) public places, a notice setting forth the time and place of said hearing and the description of the property to be considered for annexation and the purpose for which the hearing is held.

Section 3: EMERGENCY CLAUSE

WHEREAS, it is in the betterment of the public health, interest, safety, and general welfare of the citizens of the City of Albany that this matter of annexation of the property described herein be disposed of at the earliest possible moment, and, should the same be annexed, that the city facilities be made available to this property, therefore, an emergency is hereby declared to exist and this ordinance shall become immediately effective upon its passage by the Council and approval by the Mayor.
