PARK TERRACE-SOUTH LINE FIFTEENTH AVENUE TO QUEEN AVENUE, by grade and gravel, curb and gutters, asphalt concrete, drainage.

WILLETТА-SOUTH LINE NINTH AVENUE TO NORTH LINE TENTH AVENUE, by grade and gravel, curb and gutters, asphalt concrete, drainage.

ELM-NORTH LINE TWELFTH AVENUE TO SOUTH LINE THIRTEENTH AVENUE, by grade and gravel, curb and gutters, asphalt concrete, drainage.

TWENTY THIRD AVENUE-EAST LINE HILL TO WEST LINE MAIN STREET, by grade and gravel, curb and gutters, asphalt concrete, drainage.

SOUTH MAIN STREET-SOUTH LINE QUEEN AVENUE TO SOUTH LINE OF LOT 16, BLOCK 4, BIRKY BEAM ADDITION TO HOLLYWOOD ACRES, by grade and gravel, curb and gutters, asphalt concrete, drainage.

NINTH AVENUE-EAST LINE ERMINE STREET TO WEST LINE FULTON STREET, by grade and gravel, curb and gutters, asphalt concrete, drainage.

MADISON STREET-SOUTH LINE WATER TO NORTH LINE FIRST AVENUE, by grade and gravel, curb and gutters, asphalt concrete, drainage.

HILL STREET-NORTH LINE SPRR TO SOUTH LINE THIRTEENTH AVENUE, by grade and gravel, curb and gutters, asphalt concrete, drainage.

OLD OAK DRIVE, by grade and gravel, curb and gutters, asphalt concrete, drainage.

LAWNRIДGE-SOUTH LINE EIGHTH TO NORTH LINE NINTH AVENUE, by grade and gravel, curb and gutters, asphalt concrete, drainage.

SEVENTH AVENUE-EAST LINE DENVER TO WEST LINE LOT 4, BLOCK 3, HACK-LEMAN'S WOODLAND ADDITION IF EXTENDED NORTHERLY, by grade and gravel, curb and gutters, asphalt concrete, drainage.

ALLEY IN BLOCK 15 EASTERN ADDITION, by grade and gravel, curb and gutters, asphalt concrete, drainage.

CLAY-NORTH LINE FOURTH AVENUE TO OLD SALEM ROAD, by grade and gravel, curb and gutters, drainage.

FOURTEENTH AVENUE-WEST LINE WALNUT TO EXISTING PAVEMENT ELM STREET, by asphalt concrete.

EAST SIDE VINE-TWELFTH AVENUE TO FOURTEENTH AVENUE, by asphalt concrete.

EIGHTH AVENUE-EAST LINE ERMINE STREET TO WEST LINE FULTON STREET, by asphalt concrete.

FOURTH AVENUE-EAST LINE COLUMBUS TO WEST LINE ERMINE, by asphalt concrete.

HILL STREET-THIRTEENTH AVENUE TO SOUTH CITY LIMITS, by grade and gravel, curb and gutters, asphalt concrete, drainage.
