

WHEREAS, it is the recommendation of the Albany Parking Commission and Albany Police Department that certain restricted and prohibited parking be established as follows:

Restricted parking of two hours be established and signs to be installed on the following streets, from 9:00 a.m. to 4:00 p.m., Mondays through Fridays, holidays exempt; effective January 1, 1970:

- Queen Avenue from Elm to Broadway, both sides
- 16th Avenue, from Elm to Umatilla, both sides
- Umatilla Street, Queen to 14th Avenue, both sides
- Lawridge Street, from Queen Avenue to Fern Street, both sides

Prohibited parking be established and curbs to be painted yellow to designate same as follows:

Beginning at the Southwest curb corner of Waverly Drive and Pacific Boulevard and continuing westerly along the South curb line of Pacific Boulevard for a distance of 100 feet.

On Elm Street:

Beginning at a point 249 feet South of Queen Avenue and continuing for a distance of 15 feet, then beginning at a distance of 48 feet from the North curb of the North driveway and continuing for a distance of 52 feet 5 inches, then beginning at a distance of 27 feet from the South driveway of the junior high school and continuing for a distance of 30 feet, then beginning at the South line of the crosswalk in front of the Memorial Junior High School and continuing for a distance of 50 feet.

and, now, therefore,

BE IT RESOLVED by the Council of the City of Albany that restricted parking be established as follows and signs be installed:

Restricted parking of two hours be established from 9:00 a.m. to 4:00 p.m., Mondays through Fridays, holidays exempt on the following streets; effective date January 1, 1970.

- Queen Avenue from Elm to Broadway, both sides
- 26th Avenue from Elm to Umatilla, both sides
- Umatilla Street, Queen to 14th Avenue, both sides
- Lawridge Street, Queen to Fern Street, both sides

BE IT FURTHER RESOLVED by the Council of the City of Albany that prohibited parking be established and curbs be painted yellow as follows:

Beginning at the Southwest curb corner of Waverly Drive and Pacific Boulevard and continuing Westerly along the South curb line of Pacific Boulevard for a distance of 100 feet.

On Elm Street

Beginning at a point 249 feet South of Queen Avenue and continuing for a distance of 15 feet, then beginning at a distance of 48 feet from the North curb of the North driveway and continuing for a distance of 52 feet 5 inches, then beginning at a distance of 27 feet from the South driveway of the junior high school and continuing for a distance of 30 feet, then beginning at the South line of the crosswalk in front of the Memorial Junior High School and continuing for a distance of 50 feet.
