



RESOLUTION NO. 7281

A RESOLUTION OF THE ALBANY CITY COUNCIL, ACTING AS THE LOCAL CONTRACT REVIEW BOARD, WAIVING COMPETITIVE BIDDING AND AWARDED A SOLE-SOURCE CONTRACT TO MOTOROLA SOLUTIONS FOR PROVIDING VIDEO SERVER AND BODY WORN CAMERA UPGRADES AND SUBSCRIPTION SERVICE; AND AUTHORIZING THE POLICE CHIEF TO AWARD AND EXECUTE A CONTRACT WITH MOTOROLA SOLUTIONS TO PROCURE VIDEO SERVER AND BODY WORN CAMERA UPGRADES

WHEREAS, Oregon Revised Statutes (ORS) 279B.075, and Oregon Administrative Rules (OAR) 137-047-0275 allow the city council, acting as the local contract review board, to award a contract for goods and services without any competition by sole-source procurement if it is determined that the goods or services are available from one source; and

WHEREAS, such authorization must be based on written findings submitted by the department seeking the exception that describe the circumstances to support the use of the sole-source procurement as defined in ORS 279B.075; and

WHEREAS, the current video server and body worn cameras have reached an end of support and end of warranty; and

WHEREAS, Motorola Solutions is the sole provider of the Albany Police Departments video server and body worn cameras in use today; and

WHEREAS, continued use of the video system provider will allow for an efficient transition of stored data to our criminal justice partners, continued use of extensive existing data processing and transfer infrastructure, and maintain compatibility with existing interview room and in-vehicle infrastructure; and

WHEREAS, this system is in-line with the departmental strategic plans; and

WHEREAS, it is in the City's best interest to upgrade its video server and body worn cameras.

NOW, THEREFORE, BE IT RESOLVED THAT THE ALBANY CITY COUNCIL, ACTING AS THE LOCAL CONTRACT REVIEW BOARD:


Adopts the following findings:

1. Motorola Solutions is the sole provider of the software that is required for the efficient upgrade of Albany Police Department's video server and body worn cameras.
2. Continued utilization of Motorola Solutions for video server and body worn cameras by the Albany Police Department aligns with the City's strategic plan and is in the City's best interest.

SECTION 2. Notwithstanding the provisions of Albany Municipal Code Section 2.66.060, the police chief is authorized and directed to use a Sole-source Procurement method to procure the video server and body worn camera upgrades and subscription services.

SECTION 3. The police chief is hereby directed to negotiate, award, and execute a sole-source contract with Motorola Solutions for video server and body worn camera upgrades and subscription services for a term of five years after the City has given public notice for seven days of its intent to award a contract, per OAR 137-047-0275 and ORS 279B.075.


